Tyrone to Cavan (North South) 400kV Interconnector

Introduction

The planning permissions for the North-South Interconnector have now been quashed by the High Court in Belfast. The judicial review challenging the lawfulness of the permissions succeeded only on the ground that the Permanent Secretary of the Department for Infrastructure ("DFI") did not have the legal powers to determine the applications and all other grounds pertaining to the contents of the planning applications and the environmental information accompanying same were unsuccessful. As a result of the permissions being quashed, the planning applications have been sent back to the DFI for reconsideration.

Given that the planning applications were previously approved in January 2018, the DFI will now have to consider whether it is necessary to request Further Environmental Information ("FEI") from SONI to update the information previously submitted or as a consequence of a material change in circumstances since January 2018. To assist the DFI in its consideration of this issue, SONI has agreed to submit a short report to the DFI summarising the studies which it has undertaken between 2005 and 2017 in producing the various chapters of the Consolidated Environmental Statement (2013), its Addendum (2015) and material published in support of the Public Inquiry (2017). The report also identifies any known changes in the local environment, and in legislation and guidance since that time.
