### INTRODUCTION

This statement of payments sets out the payment rates for DS3 System Services in Northern Ireland for the Roll-over Contract period with effect from 1<sup>st</sup> October 2017 to 30<sup>th</sup> April 2018.

The SEM Committee published an information paper setting out the future approach for DS3 System Services. The information paper set out the SEM Committee's view that the existing Interim Framework Agreements for the 11 services, due to expire in October 2017, should be extended until end of April 2018. Following the SEM Committee's decision to extend the interim arrangements, it was necessary for the TSOs to determine a new set of tariff rates to apply for the seven month contract roll-over period.

This Statement has been prepared by SONI in accordance with Condition 30 of the System Operator Licence and has been approved by the Northern Ireland Authority for Utility Regulation (NIAUR). Words and expressions used in this Charging Statement shall have the definitions given to them in the Electricity (Northern Ireland) Order 1992, the Energy (Northern Ireland) Order 2003, Electricity (Single Wholesale Market) (Northern Ireland) Order 2007, the Electricity Regulations (Northern Ireland) 2007 or the SONI System Operator Licence, unless defined otherwise.

A party who has entered into a DS3 System Services Agreement with SONI will receive payments by reference to the payment rates set out in this statement. Payment rates shown are current at the time of publication but are subject to change without notice following revision of the statement and its approval by NIAUR.

# **DS3 System Services Payment Rates**

The table below sets out the payment rates applicable to the calculation of payments for DS3 System Services under Schedule 2 and 3 of the System Services Contract and the DS3 System Services Protocol Document.

All rates set out are exclusive of VAT at the relevant rate applicable thereto from time to time.
